BYLAW CHANGES FOR YOUR REVIEW

The current bylaws are posted on our website at: <https://www.hhcivic.org/documents>. These proposed changes will be discussed and voted on at the September General Meeting. You can review our proposed changes below:

Current Bylaws with proposed changes in red

15. THE BOARD OF DIRECTORS: The board shall consist of the Officers and the Chairman of the House Committee, ~~and five (5) Directors at Large~~ elected from and by the membership to serve for a term of one (1) year. The Director of Communications and the Rental Administrator shall be appointed by the Board of Directors annually. The chairman of the House Committee shall be elected by the members of the House Committee. Should a member of the Board be absent for an extended period, not to exceed one year, the Board may select a temporary replacement to fill this position, however, the replacement for the House Committee Chairman shall be selected from and by the House Committee. The temporary replacement shall have all voting privileges.

~~a. — Director of Communications: shall work closely with the Board of Directors to layout methods to communicate the HHCA's objectives, meetings and community events via social media, websites, newsletters, etc.~~

~~b. — Assist the Web Administrator and Beacon Editor to ensure that HHCA objectives are met.~~

22. HOUSE COMMITTEE: A House Committee consisting of **up to six (6) members**, and the rental administrator (appointed by the Board of Directors), ~~elected at the annual membership meeting for a term of one year~~, shall act as custodians of all property belonging to this HHCA. The House Committee shall elect its own chairman annually.
